### ONTARIO GOVERNMENT CHANGES TO BILL 148 AND THEIR POSSIBLE AFFECTS

You may have heard that the Provincial Government introduced omnibus legislation On Monday. As expected, Bill 47 includes a number of amendments to the Employment Standards Act, including a repeal of paid personal emergency leave (PEL) days.

### Please note the changes are not in effect until the Bill has passed and receives royal assent.

Below is a summary of key proposed changes for your information/reference:

### Employment Standard Act (ESA)

- Scheduling changes that were to be effective Jan 1, 2019 were repealed. There will still be a
  requirement to pay 3 hours if the employee shows up, but the Principal Agreement already has
  language pertaining to that (article 804).
- Minimum wage will remain at \$14 until at least October 2020 when it becomes subject to an annual inflation adjustment.
- Paid PEL days will be repealed and replaced with the following for employees who have been with an employer for at least two consecutive weeks:
  - o Three (3) unpaid days for personal illness, injury or medical emergency. Employers can request evidence reasonable in the circumstances including a medical note.
  - Three (3) unpaid days for Illness, injury or medical emergency of a family member, or urgent matter that concerns a family member.
  - Two (2) unpaid bereavement days for the death of a family member.
  - For all of those leaves, it is clear that if an employment contract provides the same benefit, the employee is deemed to have taken the leave under the ESA.

**Impact:** No paid PEL days will be required once this Bill has passed. Therefore, if you are paying 0.8% instead of paying the two days, that can cease as soon as the Bill is passed.

## Ontario College of Trades and Apprenticeship Act (OCOTAA)

- The number of apprentices to journeypersons shall not exceed one apprentice for each journeyperson.
- Moratorium on trade classification/reclassification.
- Intent to wind down OCOT. The government will develop a replacement model for the regulation of skilled trades and apprenticeships by early 2019.
